A RESOLUTION OF THE CITY OF ORONOCO, MINNESOTA
VACATING AND ABANDONING A PORTION OF THE
RIGHT OF WAY OF TWO PUBLIC STREETS

WHEREAS, the owners of certain lots in Block 14 of the Original Plat of the Village (now City) of Oronoco that lie adjacent to the right of way of Walnut Street (now First Street Northwest) and Ash Street as platted therein, to wit:

the entire width of Walnut (now Second Street Northwest) Street extending westerly from the west right of way line of Bluff Street (now First Avenue Northwest) to the termination of said street at the westerly line of said plat; together with the entire width of Ash Street extending northerly from the south right of way line of Walnut Street to the south right of way line of Elm Street;

have filed a petition with the City of Oronoco to vacate and abandon the public rights of way heretofore described; and,

WHEREAS, a public hearing relating to said public right of way vacation was held before the City Council preceded by the requisite public notice required by the provisions of Minn. Stat. § 412.851; and,

WHEREAS, based upon all of the facts and circumstances presented herein, it appears to the City Council that continued maintenance of the land encompassing the public rights of way in question as public right of ways is not required, except for the retention of a 20 foot in width public utility easement by the City on a portion of Walnut Street (now Second Street Northwest); and that the public interest would not be harmed if said public rights of way are vacated and abandoned, provided that the City of Oronoco retains in the future a public utility easement in a portion of said vacated street right of way.

Now, therefore BE IT RESOLVED BY THE City Council of the City of Oronoco that

the following described public rights of way previously platted as part of the Original Plat of the Village (now City) of Oronoco, Minnesota, are hereby vacated and abandoned, subject to the retention by the City of Oronoco of a 40 foot in width public utility easement centered on the centerline of said vacated and abandoned Walnut Street (now Second Street Northwest), to wit:


the entire width of Walnut (now Second Street Northwest) Street extending westerly from the west right of way line of Bluff Street (now First Avenue Northwest) to the termination of said street at the westerly line of said plat; together with the entire width of Ash Street extending northerly from the south right of way line of Walnut Street to the south right of way line of Elm Street.

BE IT FURTHER RESOLVED that the City Clerk is authorized and directed to note completion of these vacation proceedings to the Olmsted County Office of Property Records and Licensing as provided by law.
