**A RESOLUTION APPROVING JOINT AGREEMENT WITH ORONOCO TOWNSHIP
FOR ORONOCO ESTATES MOBILE HOME COMMUNITY (MHC)
SPECIAL ASSESSMENTS COLLECTED BY OLMSTED COUNTY
ON BEHALF OF THE TOWNSHIP TO BE PAID DIRECTLY TO CITY OF ORONOCO**

WHEREAS, Oronoco Estates Mobile Home Community (MHC) lies in Oronoco Township, Olmsted County, State of Minnesota; and

WHEREAS, Oronoco Estates MHC enjoined with the City of Oronoco to become part of the city's new Wastewater Treatment Facility as evidenced by a Joint Agreement between Oronoco Estates MHC, Oronoco Township and the City of Oronoco; and

WHEREAS, Oronoco Township held the Public Hearing on the Oronoco Estates MHC Special Assessments on November 14, 2022, and adopted the Resolution to adopt the Special Assessments to Oronoco Estates Mobile Home Community and to certify same to Olmsted County; and

WHEREAS, Oronoco Township Board has requested that Olmsted County redirect collected Oronoco Estates MHC assessments to the City of Oronoco on behalf of the Township; and


WHEREAS, the City of Oronoco is amenable to Oronoco Township's request and is willing to accept the direct payment of Oronoco Estates MHC Special Assessments from Olmsted County;


NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Oronoco Minnesota does hereby adopt this resolution approving the Joint Agreement with Oronoco Township, a copy of which is attached hereto and made an integral part hereof, allowing for the Oronoco Estates Mobile Home Community Special Assessments collected by Olmsted County on behalf of Oronoco Township to be paid directly to the City of Oronoco as permitted by Olmsted County officials; and

AND BE IT FUTHER RESOLVED that the City Administrator or her designee is authorized to take steps necessary for the implementation of this Resolution.

ON BEHALF OF THE TOWNSHIP TO BE PAID DIRECTLY TO CITY OF ORONOCO**

Oronoco Estates Mobile Home Community (MHC) lies in Oronoco Township, Olmsted County, State of Minnesota; and

Oronoco Estates MHC enjoined with the City of Oronoco to become part of the city's new Wastewater Treatment Facility as part of the city's Phase 1A Wastewater System Improvements project as evidenced by a Joint Agreement between Oronoco Estates MHC, Oronoco Township and the City of Oronoco; and

Oronoco Township Board has taken the appropriate steps leading to adopting the Assessment Roll for Oronoco Estates MHC and has or will be certifying same to Olmsted County; and

Oronoco Township Board has requested of Olmsted County that Oronoco Estates MHC Phase 1A special assessments collected on behalf of the Township should be paid directly to the City of Oronoco; and

The City of Oronoco is amenable to Oronoco Township's request and is willing to accept the direct payment of Oronoco Estates MHC Special Assessments from Olmsted County;

NOW, THEREFORE, IT IS MUTUALLY AGREED that the Township Board of Oronoco Township, Olmsted County, State of Minnesota and the City of Oronoco, Olmsted County, State of Minnesota hereby agree that the special assessments certified by Oronoco Township for Oronoco Estates Mobile Home Community to Olmsted County, State of Minnesota shall be collected on behalf of the Township and paid directly to the City of Oronoco.
