

CITY OF ORONOCO
RESOLUTION ASSESSING CHARGES TO PROPERTY TAXES PAYABLE 2023

WHEREAS, Pursuant to proper notice duly given as required by law, the Oronoco City Council has met and heard and passed upon all objections to the proposed assessments listed, plus the County fee of \$25 to each parcel for the unpaid water fees for the following properties:

- 1) SECT-17 TWP-108 RANGE-014 ORONOCO VILLAGE LOT-001 BLOCK-022 W40FT LOT 1 AND 4 BLK 22
Parcel #84.17.22.028765 – 30 Center Street SE
Assess to taxes \$1,091.41 plus \$25.00 for total of \$1,116.41
- 2) SECT-17 TWP-108 RANGE-014 ORONOCO VILLAGE BLOCK-023 E50FT W100FT BLK 23 ALSO THE N1/2 VAC WILLOW ST ADJ TO THE E50FT W100FT LOT 6 BLK 23
Parcel # 84.17.21.028772 – 120 East Center St
Assess to taxes \$496.48 plus \$25.00 for total of \$521.48

NOW, THEREFORE, BE IT RESOLVED, by the Council of the City of Oronoco, County of Olmsted, and State of Minnesota:


1. Such proposed assessment, a copy of which is attached hereto and made apart hereof, is hereby accepted, and shall constitute the special assessment against the land named therein, for the unpaid water fees in the amount of the assessment levied against it.
2. Such assessment to be payable in one installment in a period of one (1) year and will bear interest at the rate of five percent (5%) per annum from the date November 15, 2022.
3. The owner of the property so assessed may, at any time prior to certification of the assessment to the County Auditor, pay the whole of the assessment on such property, with interest accrued to the date of payment, to the City Administrator/Clerk/Treasurer, except that no interest shall be charged if the entire assessment is paid with 30 days from the adoption of this resolution.
4. The City Administrator/Clerk/Treasurer shall forthwith transmit a certified duplicate of this assessment to the County Auditor to be extended on the property tax list of the county. Such assessments shall be collected and paid over in the same manner as other municipal taxes.

AND BE IT FUTHER RESOLVED that the City Administrator or her designee is authorized to take steps necessary for the implementation of this Resolution.
