

**CITY OF ORONOCO
A RESOLUTION APPROVING OFFICIAL DESIGNATIONS**

WHEREAS, Minnesota State Statute § 412.121 states that at its first meeting each year the council shall choose an acting mayor from the council members. The acting mayor shall perform the duties of mayor during the disability or absence of the mayor from the city or, in the case of vacancy in the office of mayor, until a successor has been appointed and qualifies; and

WHEREAS, Minnesota State Statute § 412.831 states the council shall, annually at its first meeting of the year, designate a legal newspaper of general circulation in the city as its official newspaper, in which shall be published such ordinances and other matters as are required by law to be so published and such other matters as the council may deem it advisable and in the public interest to have published in this manner; and

WHEREAS, Minnesota State Statute § 118A.02 states, in part, that the governing body of each government entity shall designate, as a depository of its funds, one or more financial institutions; and

WHEREAS, it is appropriate for the council to review, and amend as may be desired or necessary, authorized signatories at the depository of its funds to allow for timely payment of its obligations; and

WHEREAS, the City of Oronoco annually appoints the City Attorney, City Auditor, City Engineer, City Planner, City Assessor, and City Building Official to ensure that the City Council has the legal and technical information to make informed decisions; and

WHEREAS, Minnesota State Statute § 18.80 subd. 2 states, in part, that (a) the mayor of each city shall act as local weed inspector within their respective municipalities and § 18.80 subd. 3 states, in part, that a municipality may appoint one or more assistants to act on behalf of the appointing authority as a weed inspector for the municipality with the appointed assistant or assistants having the power, authority, and responsibility of the mayor in the capacity of weed inspector.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Oronoco does hereby make the following official designations on behalf of the City as may be amended from time to time:


