A RESOLUTION TO ACCEPT THE PUBLIC SAFETY AID FUNDS AND EXPENDITURES

WHEREAS, the 2023 Minnesota Legislature enacted a one-time Public Safety Aid for aids payable in 2023. The one-time appropriation of \$300 million is allocated among all counties, cities, townships of a population of 10,000 or more, and Minnesota's 11 federally recognized tribal governments;

WHEREAS, as a result Recipients must use the aid to provide public safety. You can find the lists of example eligible and noneligible uses per the State of Minnesota's guidance.

WHEREAS, \$79,166 has been allocated to the City of Oronoco ("City") pursuant to the Public Safety Aid ("Allocation").

WHEREAS, the State of Minnesota has adopted guidance regarding the use of Public Safety Aid funds.

WHEREAS, the City, in response to the allocation, has had expenditures consistent with the State of Minnesota's guidance.

WHEREAS, The City Council approved expenses for the part of the purchase of a 2013 KME Fire Truck in the amount of \$43,000.

WHEREAS, The City Council approved expenses outfit and wrap the 2013 KME Fire Truck with needed safety items using the rest of the total amount of \$36,166.

WHEREAS, The City Council approved the purchase of a 2013 KME Fire Truck for \$300,000 in which \$79,166.00 of the Public Safety Aid funds were used towards that purchase.

WHEREAS, The City Council approved expenses for outfitting and wrapping the 2013 KME Fire Truck using the balance of the aid totaling the amount of \$36,166.00.

NOW THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF ORONOCO, MINNESOTA AS FOLLOWS:

1. The City intends to collect its share of Public Safety Aid funds from the State of Minnesota to use in a manner consistent with the Department of Treasury's guidance.
2. City staff, together with the Mayor and the City Attorney are hereby authorized to take any actions necessary to receive the City's share of Public Safety Aid funds from the State of Minnesota for expenses incurred.
