ASSESSING CHARGES TO PROPERTY TAXES PAYABLE 2017

NOW, THEREFOR, BE IT RESOLVED, by the Council of the City of Oronoco, County of Olmsted, and State of Minnesota:

1. Such proposed assessment, a copy of which is attached hereto and made a part hereof, is hereby accepted and shall constitute the special assessment against the land named therein, for the City of Oronoco Water Assessment in the amount of the assessment levied against it.
2. Such assessment to be payable in one installment in a period of 1 year, and will bear interest at the rate of 5% per annum from the date November 22, 2016.
3. The owner of the property so assessed may, at any time prior to certification of the assessment to the County Auditor, pay the whole of the assessment on such property, with interest accrued to the date of payment, to the City Treasurer, except that not interest shall be charged if the entire assessment is paid with 30 days from the adoption of this resolution; and he/she may, at any time thereafter, pay to the City Treasurer the entire amount of the assessment remaining unpaid, with interest accrued to December 31st, of the year in which such payment is made.
4. The City Clerk shall forthwith transmit a certified duplicate of this assessment to the County Auditor to be extended on the property tax list of the county. Such assessments shall be collected and paid over in the same manner as other municipal taxes.
