

RESOLUTION 2018-24
ASSESSING CHARGES TO PROPERTY TAXES PAYABLE 2019

WHEREAS, Pursuant to proper notice duly given as required by law. The Oronoco City council has met and heard and passed upon all objections to the proposed assessment listed, plus the County fee of \$25 each parcel for the unpaid water fees for the property of:

NOW, THEREFORE, BE IT RESOLVED, by the Council of the City of Oronoco, County of Olmsted, and State of Minnesota:

1. Such proposed assessment, a copy of which is attached hereto and made apart hereof, is hereby accepted and shall constitute the special assessment against the land named therein, for the unpaid water fees in the amount of the assessment levied against it.
2. Such assessment to be payable in one installment in a period of 1 year, and will bear interest at the rate of 5% per annum from the date November 15, 2018.
3. The owner of the property so assessed may, at any time prior to certification of the assessment to the County Auditor, pay the whole of the assessment on such property, with interest accrued to the date of payment, to the City Treasurer, except that not interest shall be charged if the entire assessment is paid with 30 days from the adoption of this resolution; he/she may, at any time thereafter, pay to the City Treasurer the entire amount of the assessment remaining unpaid, with interest accrued to December 31, of the year in which such payment is made.
4. The City Clerk shall forthwith transmit a certified duplicate of this assessment to the County Auditor to be extended on the property tax list of the county. Such assessment shall be collected and paid over in the same manner as other municipal taxes.
