A RESOLUTION OF THE CITY OF ORONOCO, MINNESOTA  
VACATING AN EASEMENT AT  
30 ENERGY LN SW IN THE CITY OF ORONOCO

WHEREAS, the Council of the City of Oronoco has been requested by Casey's General Store to vacate a drain easement at 30 Energy LN SW, to wit:

The east 10.00 feet of Lot 1, Block 1, ORONOCO CROSSINGS FIRST REPLAT, according to the recorded plat thereof Olmsted County, Minnesota, which lies 10.00 feet south of the north line of said Lot 1 and lies 10.00 feet north of the south line of said Lot 1, as measured parallel and perpendicular to said north and south lines.

AND,

The west 10.00 feet of Lot 6, Block 1, ORONOCO CROSSINGS SECOND, according to the recorded plat thereof, Olmsted County, Minnesota, which lies 10.00 feet south of the north line of said Lot 6 and lies 10.00 feet north of the south line of said Lot 6, as measured parallel and perpendicular to said north and south lines.

WHEREAS, a public hearing relating to said drain easement vacation was held before the City Council preceded by the requisite public notice required by the provisions of Minn. Stat. § 412.851; and,

WHEREAS, based upon all of the facts and circumstances presented herein, it appears to the City Council that continued maintenance of the land encompassing the drain easement in question as a drain easement is not required, and that the public interest would not be harmed if said easement vacated.

Now, therefore BE IT RESOLVED BY THE City Council of the City of Oronoco that the following described easement hereby vacated, to wit:

The east 10.00 feet of Lot 1, Block 1, ORONOCO CROSSINGS FIRST REPLAT, according to the recorded plat thereof Olmsted County, Minnesota, which lies 10.00 feet south of the north line of said Lot 1 and lies 10.00 feet north of the south line of said Lot 1, as measured parallel and perpendicular to said north and south lines.

AND,

The west 10.00 feet of Lot 6, Block 1, ORONOCO CROSSINGS SECOND, according to the recorded plat thereof, Olmsted County, Minnesota, which lies 10.00 feet south of the north line of said Lot 6 and lies 10.00 feet north of the south line of said Lot 6, as measured parallel and perpendicular to said north and south lines.

BE IT FURTHER RESOLVED that the City Clerk is authorized and directed to note completion of these vacation proceedings to the Olmsted County Office of Property Records and Licensing as provided by law.
